


The body is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The body prepares an annual return in accordance with proper practices which:



Section 1 Comparatives

The figures for 31 March 2014 in Box 3 has been restated from the figures presented on the 2014 Annual Return following the other matters noted in last year's external auditor's report. The column that has been restated should have the word 'restated' inserted beneath the '£' symbol.

Section 1 Incomplete

Section 1 box 4 for the 14/15 year was left blank, the value should have stated £3,770.
