Notes of the meeting held on Tuesday 17th January 2012.

Present were Mr Spencer, Mr J Scott, Mrs A Brooks, Mr D Wolsey and Ms M Vahl. There were two members of the public present.

Minutes – The notes of the meeting held on Tuesday 13th September 2011 were read and agreed as a true record of that meeting.

Matters arising – a) The legal ownership of the paddock is still to be established. Is it owned by WLDC, Brattleby Parish Council or by the village administered by the PC?

- b) The tree considered dangerous in the south lay-by is now known to be the responsibility of Highways.
- c) Planning, WLDC is now informing smaller parish councils by post of planning applications in their area. (We were unaware of an earlier planning application as WLDC had an old e-mail address).

Chairman's Remarks – These are covered else where in the agenda.

Correspondence – a) A survey has been received from Lincoln NHS Trust about their change of status.

- b) It was agreed to pay £35 for the ability for councillors to attend courses run by LALC.
- c) Green Grass Contracting had given us a Quote of £12.80 plus VAT per cut for mowing the paddock. It was agreed to continue with them.
- d) The chairman reported that there was a possibility that trees may be made available to replace those lost recently in Thorp Lane. BTCV may also be able to help in the clearing and planting of them.
- e) Community Links have offered to help those using oil for heating by buying in bulk.
- f) Information has been received of Npower proposing 10 turbines at Hemswell Cliff.
- g) The council has received £150 grant towards local snow clearing. It was agreed to spend some of this money on snow shovels to be stored at several locations in the village. Some money will be spent on salt this winter while the remainder will be kept in reserve for more salt next winter.
- h) Planning application 128189 had been received, see AOB.

Finance – The clerk reported that the council had an expected spend this year of £1916. Taking off the £915 cost of repair to the bus shelter this gave an expected spend of £1001. This is well within our budgeted figure, the cost of the bus shelter coming from our reserves and VAT reclaim.

The request for our precept of £1400 for the year 2012/13 was agreed and signed.

Telephone Box – Racks are being sought to make it a local book exchange and information centre.

South and North Lay-by's – The chairman is to have a meeting with Mr N Robinson from Highways with regard to both lay-bys and their improvement as an amenity.

Paddock – a) The village picnic is to be on Sunday 3rd June 2012, with the idea at present of a bring and share picnic for the village. The village to be poled to see what interest there will be.

- b) It was agreed to spend £15 on some new gorse bushes.
- c) It was agreed to replace the tree taken out which had overhung a neighbouring property with an oak tree costing up to £40. It is to be positioned so that it will cause no future problems.
- d) Concern was expressed about the removal of part of the paddock fence and the encroachment upon the paddock land of a shed. Mr Spencer and Mr Scott are to look into this with the property owner.

St Cuthbert's Church Report – K J Lipton and Son have been appointed to carry out the building work on St Cuthbert's. They are an established firm from the Newark area.

Further grants are actively being sought to bridge the funding gap.

Any other business – a) Planning application 128189

Mr Spencer declared in interest in this application and left the meeting. Mr Scott took the chair.

The meeting considered the plans and agreed that the proposed work should enhance the look of the village.
