PUBLIC TIME

- A member of the public brought up the issue of Broadband speed provided by BT. She informed the council that Superfast Fibre Optic is available to surrounding villages but left Upton out. It goes as far as the airfield then stops. Kexby is also provided, although it was agreed that Kexby is served by a different exchange. She would like a bit more pressure to be put on the providers. Clerk to write to BT to query.
- Another point was made on the appearance of the telephone box, now it is being used as a
 notice board. She commented that it looked scrappy when entering the village from
 Padmoor Lane. She suggested it being made into a more of a decorative feature, and that
 various artistic groups could take turns on decorating it. J Allan questioned who would
 undertake this role and it was suggested that the W.I. be approached and S Rose. D
 Spittlehouse to ask S Rose and Clerk to ask W.I. Also to publicise in next newsletter and get
 a rota running.

PIG REARING UNIT UPDATE

A petition was sent to WLDC with over 140 signatures of objection. A group of residents
decided to raise money to pay for a solicitor to write a formal letter on behalf of the village.
£700 was raised from donations and a collection at the Queens celebration event.

- J Allan has asked WLDC what is the next stage. It is a 16 week consultation period from closing date of application. J Allan asked R Woolass if there will be a public planning meeting or go to committee etc. Response was very vague.
- It was agreed that J Allan to write a letter to Waitrose after a member of the public informed him, that the Upton chippy was mentioned in their Good Food Guide and that if planning was agreed then it could be the end of this historic chippy. Clerk to source where and who such a letter to be sent.

the council were unsure as to who it belonged to. There is also a problem with dog fouling in that area too. The offending person/persons are known but they still continue to leave their dog poo, even when requests to remove it has been made. As it is an unadopted road there is nothing the council can do, other than to keep monitoring it and put dog fouling signs up. The resident on Hawksland Close has been informed.
